



PRODUCER AGREEMENT

(hereinafter referred to as "Agreement")

This agreement made by and between Auto International Insurance Agency (CDI# 0D44031), hereinafter referred to as General agent, and _____, hereinafter referred as a producer.

This agreement shall take effect at 12:01 a.m. _____ and shall remain in force for an indefinite period but may be terminated at any time, in writing, as provided in this agreement.

The producer is an independent contractor, not an employee of the General Agent, and subject to all requirements imposed by law, the terms of this agreement and the underwriting rules and regulations of the general agent. Producer is a broker and will represent and act as agent for producer's insured only.

Producer warrants that he is a dully licensed insurance agent/broker in accordance with the law of the State in which he transacts business and further warrants that his license is in good standing and has not been suspended, canceled or revoked in any jurisdiction within the United States. General Agent shall not be responsible for producer expenses such as rentals, transportation, clerk hire, solicitors fees, advertising, license fees, telephone, telegraph, nor any expense whatsoever.

Producer has a Binding authority in all policies he issued.

Producer shall have no authority to assign or adjust any losses on behalf of any Insurers represented by the General Agent. All claims must be reported directly to the Insurer in Mexican Territory.

Producer specifically agrees that any extension of credit by him to his client or to any other person is solely at his own risk. Producer shall pay to the General Agent all sums due when due, whether or not Producer has collected such monies from others who may owe him. Payments of premiums to the Producer shall not be considered payment to the General Agent or any of its insurers.

This agreement supersedes all previous Agreements. It may terminated by mutual agreement of the parties hereto and it may be terminated by either of the parties at any time by written notice to the other.

This agreement may be terminated in event of any return check(s) written by the Producer to the General Agent. In addition, a charge of \$25.00 will be made for each check returned.

This agreement becomes null or void if the producer enters into insolvency, change in ownership, or loss or suspension of license from the Department of Insurance.

Producer will bind coverage as of the proposed effective date on the policy, provided that the application is complete and properly signed and postmarked within no later than the proposed effective date on the policy.

Producer Code Number

Each producer has a unique producer code number. Multi-office producers will have multiple producer codes numbers. Please include producer code in all policies and correspondence.

Failure of the General Agent to enforce any or all of the provisions of this Agreement shall not be construed as a waiver of any rights of the General Agent. It is understood and agreed that this agreement shall be interpreted and construed under the laws of the State of California. This agreement shall become effective when both parties have signed, dated and had their signatures duly witnessed in the space provided below.
